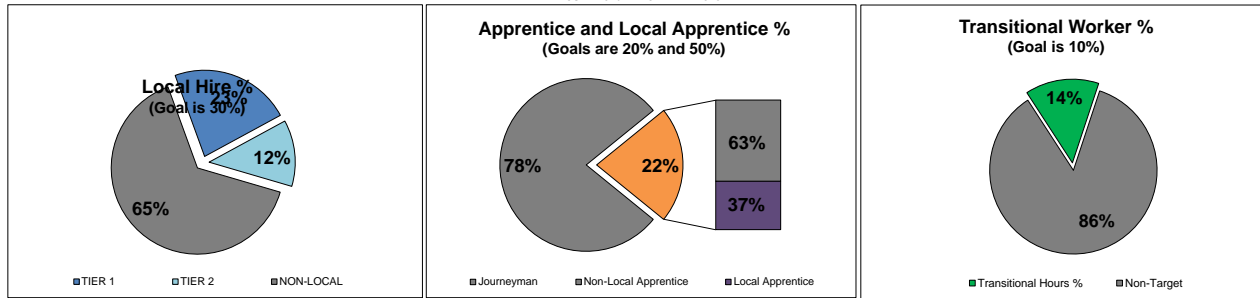

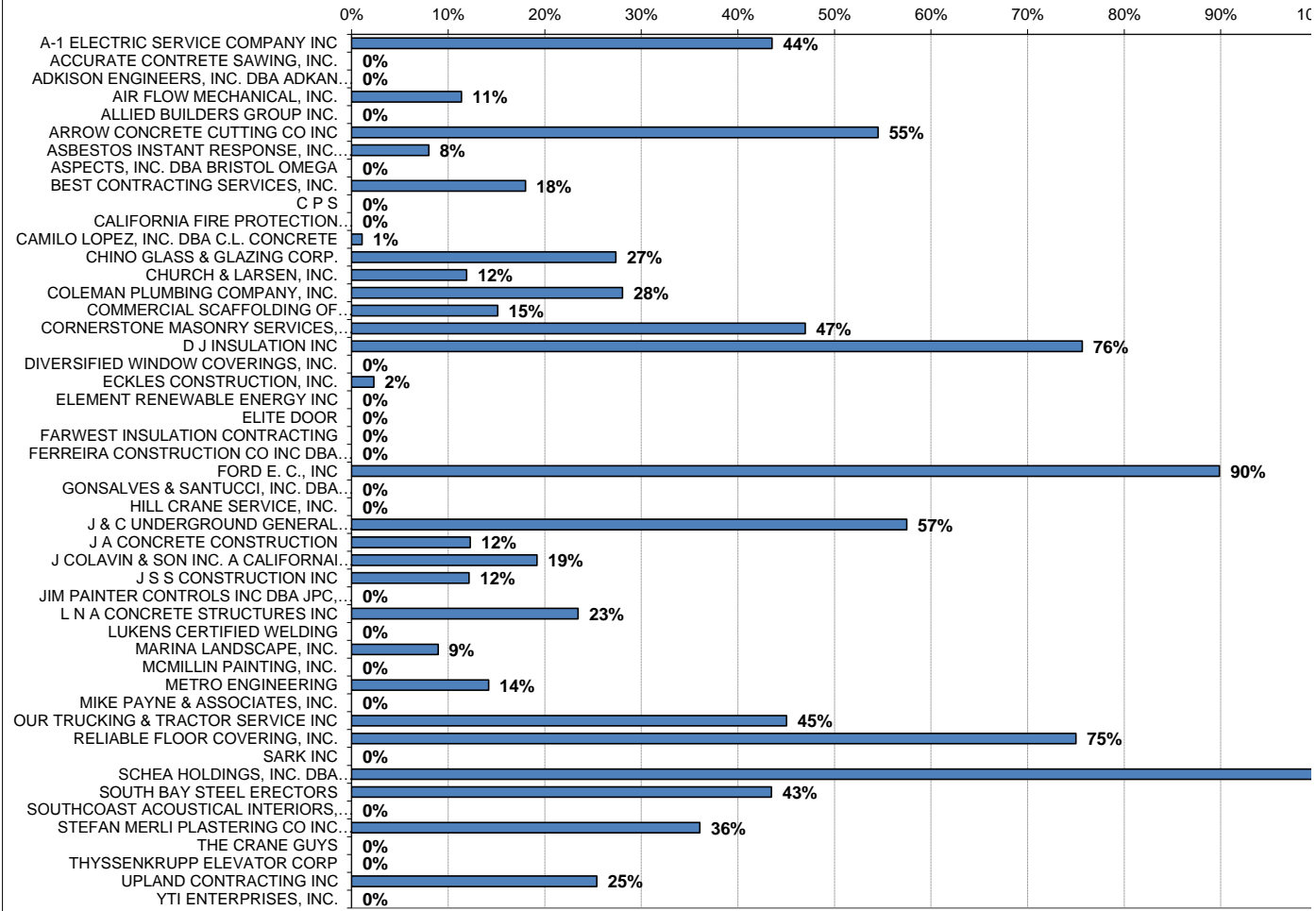
If the Jobs Coordinator or Employer is not able to identify anyone using Criteria (1), Criteria (2) may be used.

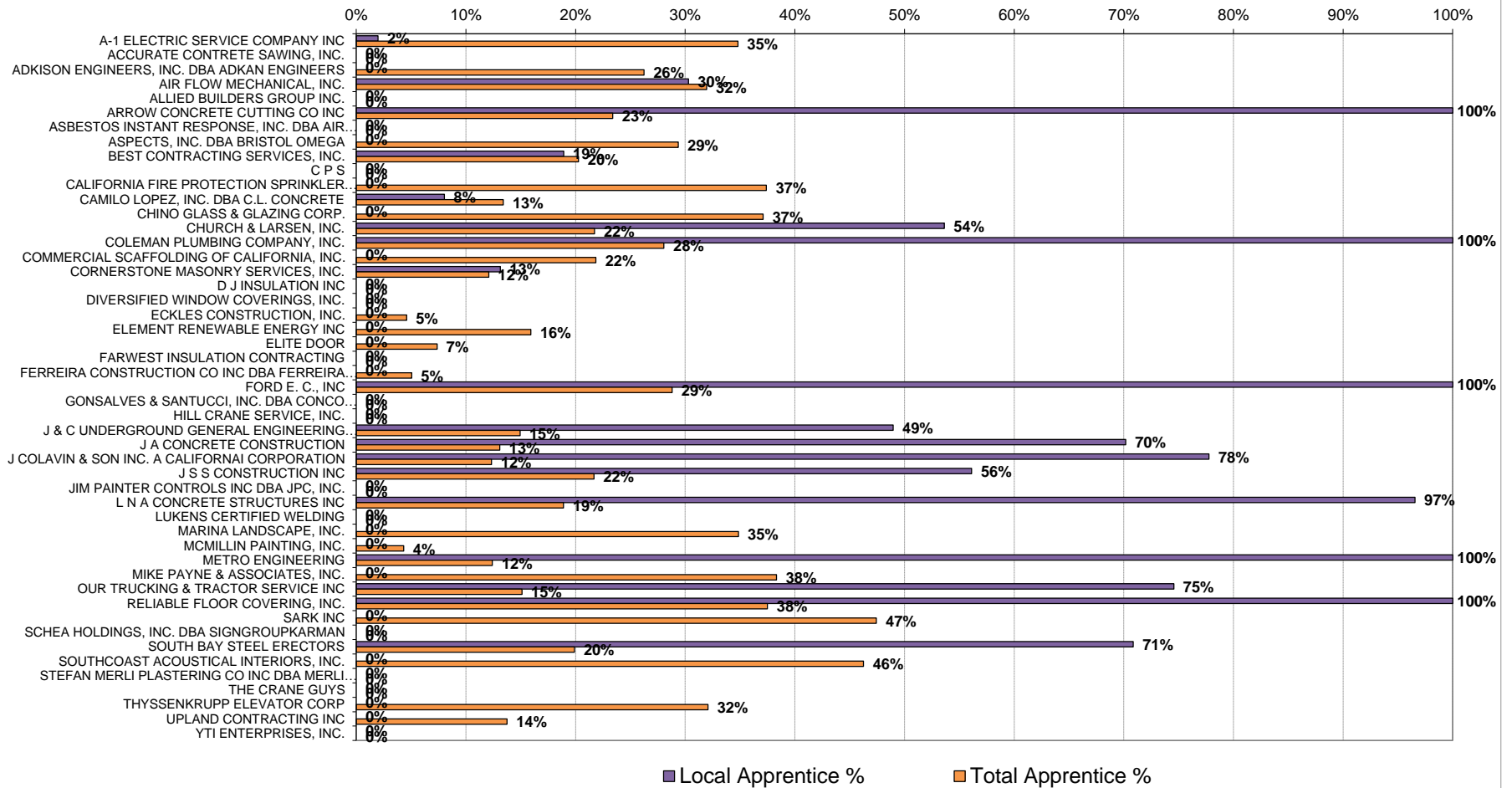

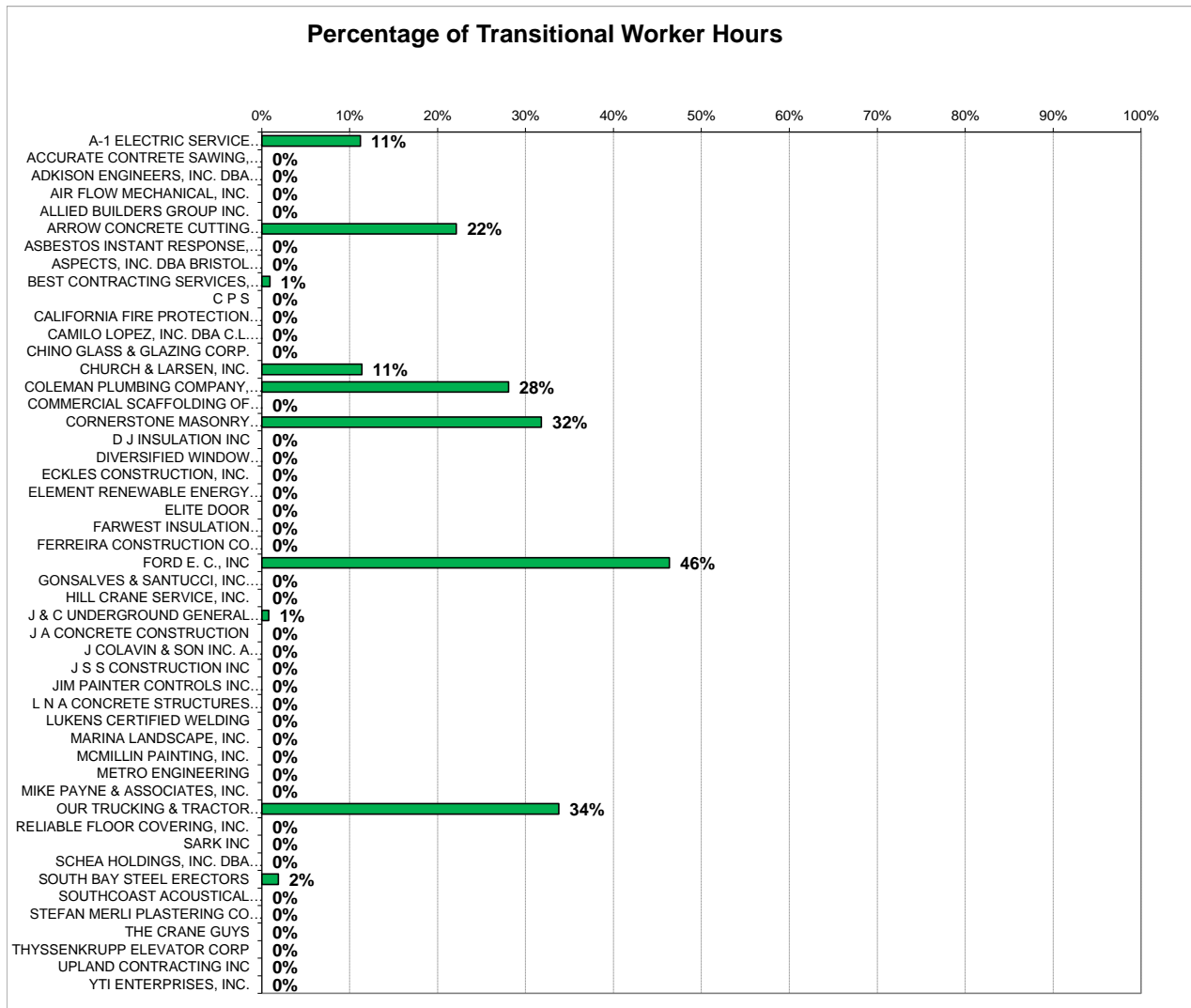
