LDEE (Harbor)\* Local Business utilized by PoLA: Firms must be headquartered

within Los Angeles, Orange, Riverside, San Bernardino, or

**Ventura Counties** 

VSBE (Harbor)\* Very Small Business utilized by PoLA: Firms must be certified

as MicroSB by the State of CA or LSB by City of LA)
